

ENVIRONMENTAL POLICY

We seek excellence in every aspect of our business and are committed to minimising the environmental impacts of our business operations. The senior management of the company have agreed to adopt the following environmental policy with a view to obtaining registration to ISO 14001: 2004 Management System.

The broad aims of the company environmental policy are to:

- identify the environmental aspects and impacts arising from the companies daily activities and assess their significance
- identify and comply with legal requirements relating to these aspects and impacts
- set objectives, targets and programme for improving the performance of the company in relation to these aspects and impacts.
- monitor performance against these targets
- review the above objectives and targets on a regular basis, taking into account changing legal and other requirements
- promote awareness, competence and training for staff and sub consultants

The specific aims in relation to the work of the company are:

- Evaluate all material in accordance with our procedures and develop recycling and recovery alternatives where practicable.
